- LMCI Abandonment Surcharge:** In addition to the tolls listed above, a surcharge is applicable to the uncommitted and the committed tolls of \$USD 0.0263/bbl and \$USD 0.0248/bbl respectively, pursuant to the NEB's Land Matters Consultation Initiative ("LMCI") MH-001-2013 Reasons for Decision. The LMCI Abandonment Surcharge is subject to periodic review and adjustment by the CER.
- Escalator:** Commencing July 1, 2025, the committed toll shall be increased annually as of July 1 each year by three percent (3%).
- Volume:** The Committed Toll Applies to Committed volumes specified in Schedule A of the TSA but does not apply to volumes Tendered by shipper in excess of their contract.
